<p>Affiliates</p>	<p>Companies related by common ownership or control, DMLO Wealth Planning, LLC and Dynamic Market Advantage, LLC.</p>
<p>Non-affiliates</p>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p>
<p>Joint marketing</p>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p>
